Bait and fishing poles are provided (**DO NOT BRING BAIT, POLES, OR EQUIPMENT**). Free fish cleaning is available. Great give-a-ways. Grand Prizes are bicycles. Prizes also received for the largest fish in each group for the boy and girl. Fishing Instruction Program, K-9 demonstrations, Fire prevention education and Smoke House, a free lunch, and interact with law enforcement and other emergency personnel. Bring a cooler of ice if you wish to keep your fish.
